Release, Disclaimer and Indemnification Agreement

I, _____ (“Artist”), hereby grant Arkansas Sculptors Guild (“ARSG”), non-exclusive permission to store, reproduce, and use photographic image(s) of Artist and Artist’s work for the benefit of promoting ARSG and the Arkansas Invitational Sculpture Show and Sale (collectively, “Event”).

Specifically, ARSG may use the images in any of the following manner:

- On a worldwide, unlimited and perpetual basis as a part of advertising and promotional materials, packaging; multimedia including web-design, broadcasting, publishing; materials for personal, non-commercial use; and/or
- Alter, crop and manipulate said images.

Specifically, ARSG may NOT use the images in any of the following manner:

- As commercial products in which the images make up a significant part of the resale value of the product (i.e. postcards, posters, calendars, etc.). For each such use of an image, ARSG must acquire express written consent of Artist;
- To promote a business that sells or licenses photographic images;
- Any manner which might be construed as explicitly pornographic, defamatory, libelous or otherwise unlawful; and/or whether directly or in context or juxtaposition with other materials.

Additionally, Artist acknowledges and understands that although security will be provided by ARSG for the duration of the Event and that every care will be taken to safeguard Artist’s work, submission of Artist’s work for display at the Event is voluntary and that ARSG, its officers and members, the Event sponsors and contributors assume no liability for any loss or damage which may be incurred by Artist or to / by Artist’s work by reason of the Artist’s participation in the Event. Artist expressly releases, acquits, and forever discharges ARSG, its officers and members, its liability insurance company, the Event sponsors and contributors (“Released Parties”) of and from any and all claims, demands, actions and causes of action, loss, costs, expenses, and any other type of damages of any kind or description whatsoever, which the Artist ever had, now has, or can, shall or may have in the future, against the Released Parties, for or by reason of the Artist’s participation in the Event.

Artist agrees to hold harmless and indemnify the Released Parties from any and all liability, losses, costs, expenses, and damages including attorney’s fees, incurred by a Released Party which arises out of Artist’s participation in said Event. Show Dates: June 17 –19, 2011

This is the sixth year for the Arkansas Sculpture Invitational. This year's show will be held in Morrilton, Arkansas. Morrilton is a unique city that combines the quality and culture of larger metropolitan areas with the warm hospitality of small town America. "**Small city, No Limits**" "**More than a motto**". Petit Jean Mountain home of Arkansas's first state park is just a short drive from downtown Morrilton.

The Arkansas Sculpture Invitational is a juried show and sale and will be open to sculptors who reside in the Mid America Arts Alliance states of Kansas, Missouri, Nebraska, Oklahoma, Texas and Arkansas. L
The show is limited to 50 Sculptors!

Acceptance notifications will be sent out February 30, 2011 and Sculptor packets will be mailed April 1, 2011

The show will be held under large tents set up on asphalt and equipped with side walls that can be closed in the event of wind or rain.

Each tent has 3 rows of 10' x 14' booths, one row down the center and one row on each side.

The show will have 24 hour security beginning Thursday, June 16, for monument setup, and continuing through Sunday evening.

There will be designated artist parking.

Upon checking in each sculptor will receive a show packet containing 2 show catalogues, artist badges and other show information.

Each sculptor will handle their own sales and are responsible for sales tax on all sales for the City of Morrilton. There will be **no commission charged on sales**. Each sculptor must provide the client with a paid sales receipt. All sculpture leaving the show must be accompanied by a paid receipt.

Each Sculptor is only allowed to display 20 works at any given time. (Sculptors may bring extra to rotate or in case of sales)

3 Dimensional original work in any medium is acceptable, (**but no erotic sculpture, no craftwork or jewelry please!**) ASI staff retain the right to request that sculptors remove sculpture that does not conform to show standards.

Booths must be manned at all times by artist, artist representative or volunteer!
